Dickinson High School Stabbing – UPDATE

Osmand Osman Miftari was located and taken into custody by Dickinson Police Department this afternoon at about 2:30 PM.

Detectives have been working with family members in an attempt to locate Miftari. Family members directed detectives to an apartment complex in Seabrook. At that time a phone call was made to Miftari and he exited the apartment peacefully and was taken into custody without incident.

Miftari was taken to Dickinson Police Department and will be transferred to The Galveston County Jerry Esmond Detention Center later today.

UPDATE:

The 15 year old stabbing victim from Dickinson High School was admitted to John Sealy Hospital in Galveston following successful surgery. On Thursday morning May 8, 2008 he was released from the hospital and is expected to make a full recovery.

The suspect in the case is still at large. Pursuant to a court order from Judge C. G. Dibrell of Galveston County Court No. 2, the suspect's name and photograph are being released in an effort to gain assistance from the public in locating him.

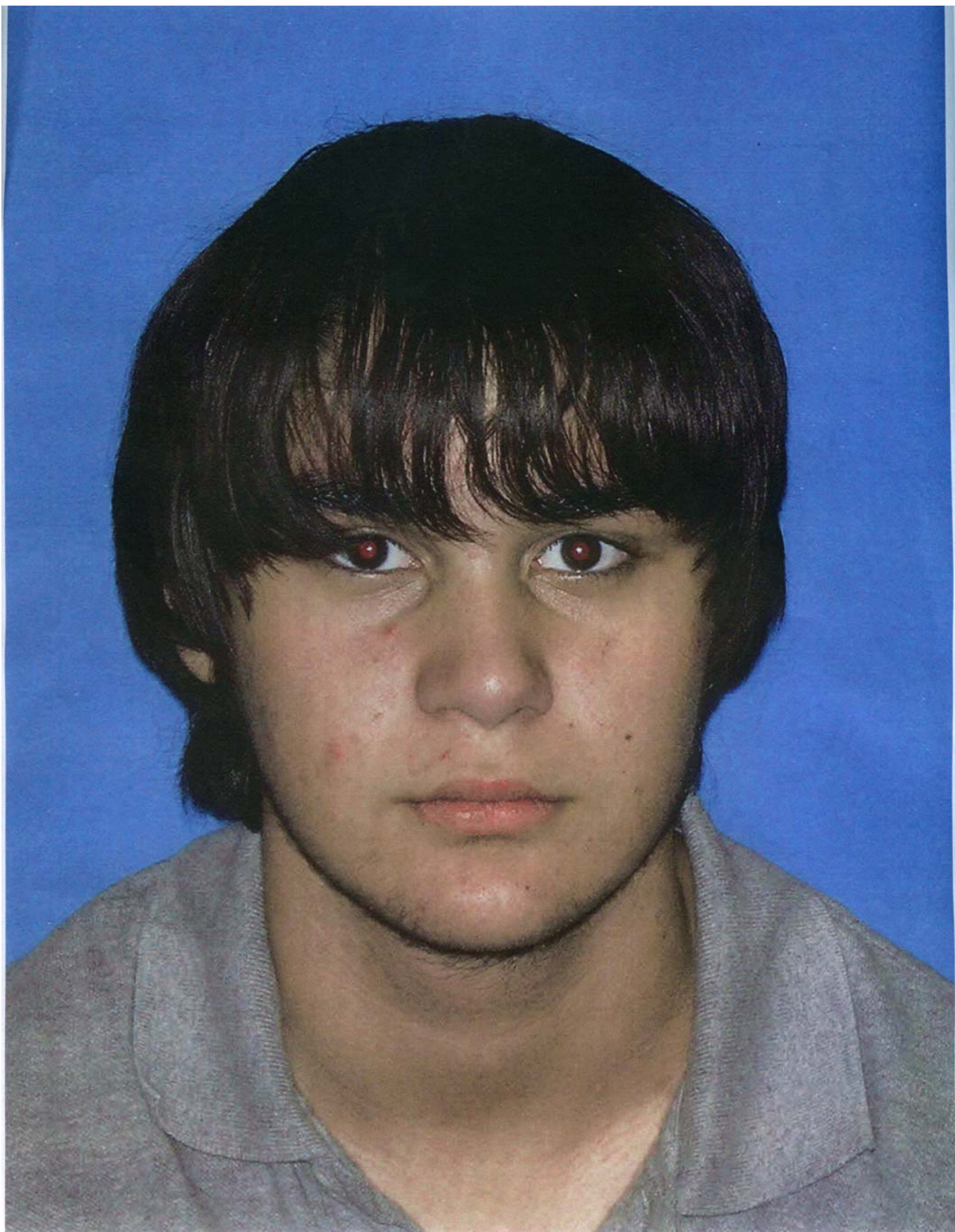

IT IS ORDERED BY THE COURT, that the following information relating to a child who is the subject of a directive to apprehend or a warrant of arrest, to wit: **OSMAND OSMAN MIFTARI**, and who cannot be located, be disseminated to the public for the purpose of apprehension, pursuant to § 58.007(h), Texas Family Code:

- (1) The child's name, including other names by which the child is known;
- (2) The child's physical description, including sex, weight, height, race, ethnicity, eye color, hair color, scars, marks, and tattoos;
- (3) a photograph of the child; and
- (4) a description of the conduct the child is alleged to have committed, including the level and degree of the alleged offense.
